CALL TO ORDER

Faye Murphy, Chairperson, called the Commission meeting to order at 6:30 PM.

APPROVAL OF THE MINUTES

1. Consider approval of the following Beautification Commission minutes:

a) April 15, 2013 regular meeting.

NEW BUSINESS

2. Discuss planning for 2014 Calendar.

The Commission agreed that Clean Up Bedford (CUB) Day needs to be on the calendar earlier due to difficulty obtaining volunteer workers for this year's event. This will allow subcommittee members to provide dates to school organizations to be placed on their annual calendars. Tentative dates are:

5. Discuss update on the Community Garden.

He mentioned difficulties with the spigots used to water the beds, and the commission suggested taking the subject to the next 6Stones meeting, which Faye Murphy will also attend. Members asked for clarification on crop donation times at 6Stones, as crops are growing and are already being harvested.
