2. **Discussion and possible action on greenhouse repairs.**

Don Henderson provided quote information from another contractor regarding the greenhouse repairs. A quote of \$10,810.00 was received from Michael Baldwin to do the necessary repair work. This quote is half the cost of the previous contractor quotes. The current greenhouse is a Stubby Greenhouse and the installation was done by Michael Baldwin, who was a private contractor for Stubby Greenhouse.

Discussion was held regarding the benefit gained from restoring the greenhouse and using it to start seedlings to plant versus purchasing plants at local nurseries. Discussion was also held concerning what are the long-range plans of the Beautification Commission and would

they include use of a greenhouse. Patty Sinclair moved to table the discussion for next meeting, Glen Mizell seconded the motion. Motion passed.

3. Discussion and possible action on nominations for the Beautification Awards program.

June Gravely submitted a home nomination at 876 Lee Drive, 76022. Glenn Mizell motioned to accept the home nomination and Patty Sinclair seconded the motion. Motion passed.
